Indiana	CBD derived from hemp with a THC content of 0.3% or less is permissible, its cultivation, manufacturing, and retail sale through dispensaries remain strictly prohibited. Kansas	Both recreational and medical use are illegal, carrying potential jail time and fines. Even CBD is restricted to low-THC hemp-derived oil.	Kansas Marijuana Laws 2024(opens in a new tab)
Nebraska	Possession of small amounts has been decriminalized, and the state is actively considering two legislative bills that could further loosen restrictions. One proposes a full-fledged medical marijuana program, while the other aims for broader adult-use legalization. For now, hemp-derived CBD products with minimal THC content are legal. North Carolina	While recreational use remains illegal with possession penalties, limited exception exists for low-THC hemp extract for specific epilepsy cases. However, Senate Bill S3, the NC Compassionate Care Act, proposes establishing a comprehensive medical marijuana program. The bill is still under consideration as of January 2024. South Carolina	Illegal for both recreational and medical use - even exceeding 0.3% THC in CBD products. Cultivation and manufacturing are off-limits too. A single exception exists: epilepsy patients can legally use low-THC CBD for treatment. Future legislation has been stalled due to the use of the Mexican derived word of "Marijuana" and efforts are underway to push legislation forward with use of the more socially accepted term of "Cannabis". Tennessee	Both recreational and medical marijuana remain illegal, with possession of any amount carrying potential jail time and fines. Even CBD is restricted to products containing less than 0.3% THC. Growing and manufacturing are equally prohibited.	Tennessee Marijuana Laws 2024(opens in a new tab)
Texas	Both recreational and medical use remain illegal, punishable by fines and jail time, regardless of the quantity or form. Growing, manufacturing, and distributing cannabis are also strictly prohibited. Although CBD products are legal, they must contain less than 0.3% THC.	Texas Marijuana Laws 2024(opens in a new tab)
Wisconsin	Both recreational and medical marijuana are illegal, meaning possession of any amount can result in criminal charges. This extends to hemp-derived CBD with more than 0.3% THC.	Wisconsin Marijuana Laws 2024
